<u>Status Update on the</u> <u>Capital Projects Sales Tax</u>

Conway, South Carolina – Since the voters of Horry County passed the Capital Projects Sales Tax Referendum in November 2006, many objectives and projects have been accomplished

Since Horry County will not receive its first quarterly payment from the South Carolina Department of Revenue until October 2007, Horry Councy Council passed a resolution authorizing the county administrator to loan cash from the General Fund to the Capital Projects Sales Tax Fund to begin paying for related costs associated with the road projects so work could begin immediately. The loan was not to exceed \$7.9 million. The South Carolina Budget and Control Board of Economic Advisors is estimating the tax will generate about \$425 million over the seven-year lifespan of the tax.

The Horry County Engineering Department is conducting the resurfacing work on the roads that were approved in the Capital Projects Sales Tax referendum. Work has been completed on the first 12-mile grouping of roads (see attached list) on August 2, 2007, at a cost of \$840,003.05, which was \$75,000 under budget. The next 12-mile grouping is expected to begin in 2008.

Horry County Council also passed a resolution on May 15, 2007, to enter into an intergovernmental agreement with the South Carolina Department of Transportation (SCDOT) to act as project/construction manager for those named state highway projects included on the road list. Those road projects include (1) a grade separated interchange at the intersection of US Highway 17 Bypass and SC Highway 707 at the backgate of the former Myrtle Beach air base; (2) widen SC Highway 707 from Enterprise Road to the county line including intersection improvements at SC Highway 544; (3) construction of the Aynor Overpass; and (4) widen Glenns Bay Road to 3-lanes and construct a grade separated interchange at US Highway 17 Bypass.

As project/construction manager, the SCDOT will prepare for each project listed above a detailed scope of work, budget and schedule based upon three phases for each project: (a) design, preliminary engineering and environmental work; (b) right-of-way acquisition; and (c) construction.

Proposals from consultants have been received for the Aynor Overpass project and the selection of a consultant is anticipated in October 2007. A signed contract and notice to proceed is expected to take place in November 2007.

A consultant was selected in July 2007 for the US Highway 17 Bypass/SC Highway 707 (Backgate) Grade Separated Interchange project, and the SCDOT is currently in contract negotiations and expect to have a contract signed and a notice to proceed in October 2007.

Field surveys and preliminary designs are currently in progress for the SC Highway 707 Widening project and information is being gathered for advertisement for design consultants for the Glenns Bay Widening project. Consultant selection is anticipated in December 2007.

Horry County has also negotiated and signed a contract with RPM Engineers to pave the first group of 20 miles of county dirt roads, which consists of 50 projects. RPM will act as construction manager and will prepare a detailed scope of work, budget and schedule for these 20 miles of county dirt roads. These roads are currently in the design phase and construction is slated to begin in the fall of 2007 with anticipated completion in April 2009.
